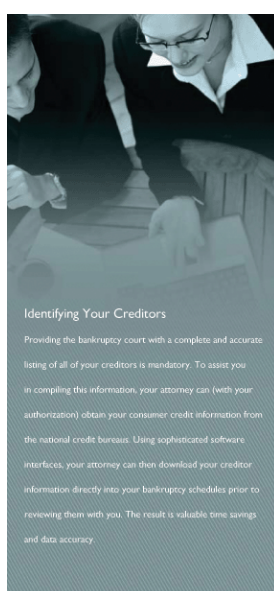
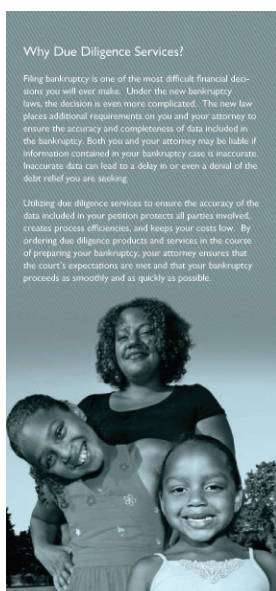
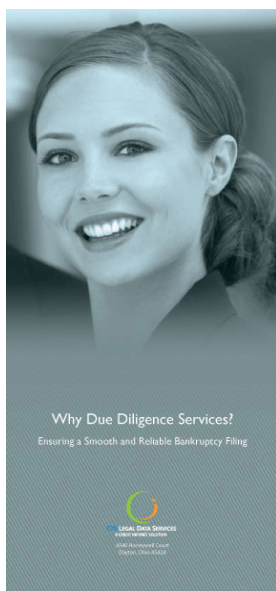

CIN Legal Data Services F.A.Q. & Helpful Hints...

Question: Does my client have to sign anything to obtain a copy of his / her tax transcripts?

Answer: Yes. The Internal Revenue Service requires a signed 4506-t form from the consumer(s) desiring a copy of their tax transcripts. When ordered via CIN Online, CIN Legal Data Services delivers to the attorney a pre-populated 4506-t for signature by their client. Once the 4506-t is signed it may be faxed to CIN Legal Data Services. Completed tax transcripts are delivered in 24 – 48 hours.

Question: How do I authenticate my client for the Post-Discharge Consumer Liability Report?

Answer: Once an attorney's account is set-up for the Post-Discharge Consumer Liability Report and Bankruptcy Verification Package, the online authentication module will present the client with new language authorizing Credit Infonet to monitor the court records for discharge and subsequently order the post-discharge report. Thus, no additional authentication process is required to order this product.

Question: I lost my paper invoice. Can I view my current balance online?

Answer: Yes. Current balance information may be viewed online at www.cinlegal.com. Once logged in, simply navigate to the **Tools** section using the icon located at the top of the application. Within this area of the application, current bill information and payment options are presented.
